(4) Description

Please provide a brief description of the proposed site, including the physical characteristics. 200 words

The site occupies the most culturally and historically significant part of the former island of Derry - a low hill at the head of the Foyle Estuary, defined on one side by the River and on the other by a silted up former course (the Bogside).

It includes the location of an important monastic city which was completely replaced in the Seventeenth Century by a colonial foundation on its northern slope. This retains the full circuit of its walls (1 mile in length, enclosing 13 hectares), ideal street layout and cathedral. Symbolic as a representation of the new order, it evolved to become a wider symbol of Ulster Protestant identity following three sieges. This symbolism is reinforced by key buildings and monuments.

The site however also illustrates attempts to highlight the lost glories of the medieval city by the opposing Catholic and Nationalist population. The most recent conflict in Northern Ireland, deeply influenced by this history, is also tangibly reflected in surviving fabric within the wider area. The site was the location for many key events, and has evolved to become a symbol of the respect for diversity upon which the current peace is based.

Since the partition of Ireland Derry has been a border city, but for most of its history it was the chief settlement in the north-west, with an extensive hinterland.

(5) History

Please provide a short summary statement of any significant events in the history of the site. 200 words

'Doire' is Gaelic for 'Oak Grove' and reflects the ancient sacred significance of that tree. This grove existed until the late Middle Ages when the site was an important monastic foundation with links to St Columba - the first saint of Irish birth. The Plantation imposed new laws, customs, religion and language upon what was the most Gaelic part of Ireland. The new order, funded by the livery companies of London, was most clearly represented by their principal settlement at 'Londonderry'. The 400th anniversary of this link will occur in 2013.

This walled city withstood three sieges in the Seventeenth Century siding with Parliament in 1645 and William III in 1689. That 108 day event in particular, was crucial to the development of an Ulster Protestant identity and was where the cry 'no surrender' was coined.

In the Eighteenth and Nineteenth centuries, the mercantile aims of the settlement were largely realised and its founding myths reinforced through buildings and traditions. Opposing myths were also cultivated.

In the Twentieth Century these historic divisions erupted. The city is often seen as the birthplace of the Troubles and witnessed many of the key events.

It was also, where the civil rights movement began and attempts at 'power sharing' were first developed, setting a template for the current peace.

(6) Why do you think this site should be inscribed as a World Heritage Site?

Derry-Londonderry is a significant example of an ideal city. When the new 'London' was built at Derry, the city was designed on classical principles, based on ideal Platonic ideas of order. The streets were proportioned according to simple mathematical relationships with a perfect square (The Diamond) at the centre.

Derry~Londonderry is also the place that best articulates the creation, development and transformation of cultural divisions within Northern Ireland. The city stands out as an example of such divisions and their resolution - moving from a disputed past to a shared future. It is the blend of the existing tangible historic asset of the Walled City and its environs with the intangible story of people and place which provides this outstanding universal value.

The construction of the Walled City was integral to the plantation of Ulster which resulted in divisions which have continued to the present day. The London Companies were unwilling participants, but their participation provided one of the most lasting and obvious conflicts - the disputed name of the city itself. The building of understanding and shared ownership of the historic city is part of a wider transformation of attitudes in Northern Ireland and an important part (and symbol) of the process of reconciliation.

(7) Please say why the site has Outstanding Universal Value and specify the main features which underpin its importance. 200 words

The site has OUV because it is a tangible representation of the ideals and problems of the initial era of European colonial expansion, the implications of such policies, and of the potential to use such assets to illustrate the complexity of history and promote peace.

Main features and examples include:

The scant surviving fabric of the medieval city.

The 17th century ideal city plan and associated archaeology enclosed by a complete circuit of walls, representing a utopian vision of what a post medieval city, focused on mercantile activity, should be like.

Buildings and monuments illustrating the divisions created by the Plantation i.e. its history of sieges, celebration and opposing traditions - which contributed to the partition of Ireland in the 20th century.

Buildings and monuments illustrating the success of initial mercantile aims in the Eighteenth and Nineteenth centuries.

Buildings, structures, and former bomb sites which reflect the continuation and reinforcement of divisions following the partition of Ireland and during the Troubles of the late Twentieth Century.

Buildings and cultural institutions which illustrate how divisions have been transformed more recently through an acceptance and celebration of diversity.

(9) Authenticity (for cultural or mixed sites only)

Authenticity concerns the current state of conservation of a cultural or mixed site; especially whether its importance, its Outstanding Universal Value, is still obvious from its physical condition. Please outline the condition of the site. 200 words

The site clearly reveals its outstanding universal value. Most importantly the city walls, plan and cathedral remain intact. Changes to the walls to construct new gates have reinforced the cultural story of the plantation, siege and their symbolism. The mercantile city is reasonably well preserved as are key buildings and monuments which illustrate the celebration of the founding tradition. Important structures which reveal the development of an opposing nationalist story based upon a reconstruction of medieval history are also preserved; as are sites associated with the more recent Troubles such as commemorative murals, monuments and a 'peace wall'. Some modern development, though inappropriate aesthetically, can be understood as a product of the economic aspect of this conflict with its associated bombing (and rebuilding) campaigns. The transformation of this conflict is represented in the establishment and ongoing development of a series of museums and cultural institutions around the walls. Managed by differing communities, these give different perspectives on the past, and explain the wider story and significance of Derry~Londonderry.

The focus of this site is its city walls (built 1613-18), their plan form and associated historic buildings and monuments which together illustrate the Outstanding Universal Value of a place which has seen: the imposition of a utopian colonial settlement ; the ramifications of this for future generations and a solution evolved from the resultant divisions, and based upon a celebration of diversity. The integrity of this story is clear in the surviving historic and modern structures which are closely associated with and clearly illustrate this evolution. In the context of this argument, original fabric is important in as far as it illustrates the story. Thus the replacement of an original gate by a new triumphal arch 100 years after the siege or the careful reconstruction of part of the symbolic Guildhall after a bomb in 1972 are both important and integral parts of the site's OUV.

A number of sites share some of the characteristics - but none share all.

The list includes a range of 'colonial' settlements, reflecting different aspects of empire building such as Zamosc, Palmanova and Jacarta. However the Derry~Londonderry site is not primarily about preservation of a colonial site. It is the implications reflected in its buildings over time which give it most interest.

In this respect the closest parallels are those which examine cultural reconciliation, such as the symbolic rebuilding of the bridge at Mostar, or the story of division and reconciliation told at Robben Island.

(12) What distinguishes this site from other similar sites?

The importance of Derry~Londonderry is that it tells, in microcosm, the origins and history of a conflict and a process of reconciliation, which has global relevance, and is perceived as an example to other places.

There are sites which reflect different aspects of 'colonialism', or 'snapshots' of a civilization. In the case of Derry~Londonderry the building of the city walls marked a turning point. As a result, almost 400 years in the future, Derry would become the birthplace of the civil rights movement, and then the crucible of the troubles. In telling this story the city has devised a framework for the convergence of culture and heritage for the articulation of the story of this place.

(13) How does the site contribute to meeting UNESCO’s priorities for a balanced World Heritage List?

Derry-Londonderry's inclusion in the new UK Tentative List will exemplify how the UK have responded to UNESCO's need to address the gaps in the World List by 'encouraging the nomination of properties that better reflect regional cultural identities, significances and values.' The cultural quality of this story as articulated through the site's physical heritage has Outstanding Universal Value.

The story of 'Plantation-to-Peace' is of major importance in such a context and in our opinion is better articulated in this place than anywhere else. The site demonstrates the ideals and consequences of colonialism and that it is possible to overcome the division and conflict of previous generations. It shows how attitudes can be reinforced by buildings but also how a place can be transformed into one of shared ownership with a new symbolism. This process has had high levels of engagement, with the involvement of a wide range of stakeholders that has allowed understanding to develop, culminating in a range of physical restoration and renewal projects.

Conservation and Protection are the key benefits. The majority of the site is protected under designations aimed at preserving individual historic buildings, historic areas or monuments. The city walls are maintained by the Government as a Monument in State Guardianship. Most of the area lies within a Conservation Area and an Area of Archaeological Potential. Many historic buildings are individually listed. All these designations however are based upon an assessment of tangible architectural and historical attributes. The World Heritage Site proposal seeks to move beyond this to also value a more intangible story of universal value which links these structures and other previously less valued monuments to the more recent cultural and interpretative developments. Collectively this constitutes a new way of appreciating and valuing this overall site which will be reflected by the development of more holistic management structures.

Protection of City Walls as a Monument in State Guardianship 1955 - following agreement with the owners of the walls, the Honourable the Irish Society.

Derry Area Plan 2011 - framework for planning decisions in the city and surrounding area. Designates most of proposed site as 'an area of archaeological potential', which ensures consideration of any archaeology to emerge in redevelopment in this area.

Protection of the Walled City as Conservation Area - designation in 1977, and area expanded in 2006.

Public Realm Plan - by Derry City Council and Northern Ireland Tourist Board - looks at how best to use public realm including walls to promote tourism.

NITB Walled City Designation - the 'Walled City' has been designated as 1 of 5 'standout destinations' for visitors to NI.

City Walls Conservation and Management Plan - sets out the the importance of the City Walls, provides historical and architectural detail, and sets out policies for conservation and management.

Built Heritage Project - 6 key historic buildings within the proposed area were

identified for restoration.

Townscape Heritage Initiative - partnership programme to identify and restore historically important, but usually less prominent, buildings in designated areas.

Regeneration Plan 2010-20 - will take into account the issues raised in this application.
